AMENDMENT TO THE AMENDED DECLARATION OF PROTECTIVE COVENANTS, RESTRICTIONS PARTY WALL EASEMENTS AND RECIPROCAL PARKING EASEMENTS FOR RIDGEPLEX COMMONS

The Amendment set forth below is made to the Amended Declaration of Protective Covenants, Restrictions Party Wall Easements and Reciprocal Parking Easements for Ridgeplex Commons (the "Declaration") which was recorded in the Monroe County Clerk's Office at Liber 6840 of Deeds, page $29\,$ 0.

A majority of not less than eight (8) of the ten (10) lot owners in Ridgeplex Commons demonstrated their approval by signing on Schedule A attached hereto, to amend the Declaration at Article 10.

The following paragraph will be inserted at the end of the text of Article 10:

The owners shall be obligated to pay for the maintenance, repair and replacement of the sewer lines at Ridgeplex. In order to facilitate such payment each owner shall pay one-tenth (1/10) the cost of such maintenance, repair and/or replacement as billed by the Association.

The owners shall not be obligated to pay for the maintenance, repair and replacement if the sewer lines are damaged by the willful act or negligence of the Owners of any lot, or their guests, agents or invitees.

This instrument is prepared and recorded to make the above Amendment to the Declaration effective as provided in Article 22 of the Declaration.
