FIRST AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS OF WOODCLIFF HOMEOWNERS ASSOCIATION, INC.

This Amendment is made this 12th day of November, 1992, by the undersigned members of Woodcliff Homeowners Association, Inc., being 90% or more of the owners of all the lots in the subdivision known as The Fairways at Woodcliff, Section I.

This Amendment amends the Declaration of Covenants, Conditions and Restrictions (the "Declaration") dated October 15, 1987, recorded in the Monroe County Clerk's Office on October 16, 1987, in Liber 7211 of Deeds, at page 166.

NOW THEREFORE, the undersigned hereby amend the Declaration as follows:

- 1. Article III is amended as follows:
 - (a) Sections 1 and 3 are deleted in their entirety.
- (b) Section 4 is amended by deleting the last sentence of Section 4 beginning "An easement is hereby reserved to Declarant . . " through the end of the section.
- (c) Sections 2 and 4 are renumbered to be Sections 1 and 2, respectively.
 - 2. Article VIII is amended as follows:

(a) Section 1 is deleted in its entirety and the following is substituted as new Section 1:

Section 1. Advertising and Signs. No sign or other advertising device of any nature shall be placed for display to the public view on any lot or other portion of the Properties (including temporary signs advertising property for sale or rent) except with the consent of the Board of Directors or the Architectural Review Committee if one has been appointed by the Board.

- (b) Section 9 is amended by deleting the last sentences thereof which states: "This Section shall not apply to the Declarant."
- (c) Section 10 is deleted in its entirety and the following is substituted as new Section 10:

<u>Section 10</u>. <u>Residential Use Only</u>. Except as provided in Section 11 below, the Property shall be used only for residential purposes

and purposes incidental and accessory thereto.

(d) Section 11 is deleted in its entirety and the following is substituted as new Section 11:

Section 11. Commercial and Professional Activity on Property. No wholesale or retail business, including any salon, studio, laboratory, home industry or medical or dental office, shall be conducted in or on any Lot or other portion of the Property except the conduct of business by telephone. This restriction is not intended to preclude the operation of an in-home office for purposes other than those set forth above.

3. Article XI is deleted in its entirety and the following is substituted as new Article XI:.

ARTICLE XI

ADDITIONS TO PROPERTY OF THE ASSOCIATION

Annexation of additional property by the Association shall require the assent of 75% of the Owners, at a meeting duly called for this purpose on the same notice, and in the same manner, as is required for meetings and voting by the By-Laws. Any property so annexed must be subjected to this Declaration by recording in the Monroe County Clerk's Office a Supplemental Declaration extending this Declaration and any amendments thereto to such annexed property, and the annexation shall not be deemed effective until such document is recorded.
