

#### **Schedule B Rules and Regulations:**

above, individual Owners are responsible for the interior and exterior maintenance of their Lots and Homes. Since some Homes have shared driveways and roofs, should any disagreement occur between Owners, the Board of Directors will facilitate a settlement between the Owners. If Homes are not appropriately maintained by the Owners, then the Association, after notice, may maintain the Home and charge the Owner the cost of performing the maintenance, said charge shall be deemed a Maintenance Assessment and payable as such, and if unpaid the Association shall have the same rights and privileges as for the non-payment of Maintenance Assessments, including without limitation the right to place a lien on the Home and Lot and foreclose the lien.

#### **General Covenants and Restrictions XI**

Section 11.11 Trees and Other Natural Features. No trees shall be removed from any Lot or portions of the Association Properties/Common Areas, except with the consent of the Board of Directors of the Association. The Board of Directors of the Association, in its discretion, may adopt and promulgate rules and regulations regarding the preservation or replacement of trees and other natural resources and wildlife upon the Association Properties/Common Areas.

## **Section 11.23** Lot Owner Improvements

Holiday ornaments and decorations shall be permitted for the holiday season only. The holiday season is defined to be 30 days before and after the holiday.
